Program Details:

Degy's Internship program is designed to provide a well-rounded experience for participants looking to gain experience in the Music and Entertainment industry. Teams: Interns will be placed on either an Agent Team, Finance Team, or a Marketing Team. This will be the main day-to-day responsibility and where most deadlines and assignments will come from.

- **Agent Training Team:** On this team, you will be placed with one of our senior agents and their assistants based on areas of interest. Through lead generation and market research, you will learn how to develop different sectors of Degy, build brand awareness, enhance your customer service and sales skills, and learn more about entertainment booking. From roster acts to major talent, you will gain a better understanding of the show process from conception to execution.
- **Finance/Accounting Team:** This team gives interns with a "numbers" background a first-hand look at how money flows in an entertainment booking agency. Utilizing excel, QuickBooks and our own internal programs, you will assist the Finance Director in all things business management from customer invoices to sales analysis to expense reporting and gain an understanding of how things operate from a finance standpoint. Accounting coursework or experience helpful.

- **Marketing Team:** **NOT OFFERED THIS SUMMER 2023** Our marketing team consists of a strategic, creative, and analytical perspective where you will focus on marketing strategies and creative branding, with specific areas of interest that include Graphic Design, Social Media Management, Content Creation, Website Optimization, SEO Strategies, Google Analytics, and the overall Marketing & Advertising of Degy Entertainment and the overall Marketing & Advertising of Degy's Family of Companies.

Wage/Salary:

Days/Hours Per Week:

The internship program lasts for 20 weeks, and applicants MUST be committed to working a minimum of 10 hours and at least 3 days a week but are highly encouraged to put in more to take advantage of the program. Time requirements are flexible based on the intern’s schedule or outside responsibilities but are required to attend two meetings a week.
